Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 6 (2 sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 20 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has submitted two recognition certificate from I to V and VI to VIII. However, notarized translation of the recognition certificate from VI to VIII is appearing not to be submitted, as in the said certificate dated 03-07-2019 there is clause mentioning 36 (6), which is a one page certificate. However, in the notarized translation, permission is given under section 31 . Therefore is a mismatch between the certificate of class for VI to VIII and its translation submitted. The school is required to submit the correct recognition certificate from class VI to VIII along with its notarized translation within 03 months in the compliance.
3	The Land Certificate is issued in 2018 and it does not specify the period of the lease , therefore the school is required to obtain a revised Land Certificate as per Appendix X clearly mentioning the time period of the lease and submit within 3 months in compliance on SARAS Portal.

4	The Building safety certificate does not have the validity , therefore the school is required to obtain a revised Building Safety Certificate with period of validity and submit within 3 months in compliance on SARAS Portal.
5	The School is required to install railings on both sides on the ramp at the ground floor and submit compliance within 3 months in SARAS Portal..
6	(i)The Composite Science Lab. Chemistry Lab, Physics and Biology Lab have curtains which may pose as a fire hazard . (ii)The Composite science lab has side tables being used as demonstration tables, which may not be appropriate for conducting practical. Further, the Composite Science lab is set-up on temporary tables without any washbasin and gas connection on the demonstration tables. The School is required to remove the curtains from the labs and upgrade the composite Science lab in the light of the Board's SoPs for Labs and submit compliance within 3 months in compliance on SARAS Portal.
7	The Maths Lab has inadequate seating therefore the School is required to upgrade the same in the light of the Board's SoP for Lab and submit compliance within 3 months in SARAS Portal.
8	The school shall conduct training of its teachers with CoE Bengaluru within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
